****In accordance with T.C.A. 29-8-102, you must be a resident of Wilson County Tennessee to petition for a name change or birth certificate correction.***

- The Form for an Adult Name Change can be downloaded from wilsoncountycourts.com
- Circuit Court requires the petition to first be filed and then you are responsible for calling or emailing Connie Ford, Judicial Administrative Assistant to Judge Clara Byrd, (615-449-7170) (connie.ford@tncourts.gov) for a hearing date.
- Once the Order is entered it is your responsibility to submit the Order to the appropriate agencies. Certified copies of the Order will be provided.

DOCUMENTS TO BRING WITH YOU

- Completed Petition for Adult Name Change and completed Order forms.
- A copy of your birth certificate.
- Photo identification (such as a driver's license, passport or comparable photo identification.)
- Social Security card
- Proof of residency in Wilson County. Such proof may be a current lease, payroll stub, recent utility bill or similar document.
- \$192.00 cash or cashier's check (no personal checks accepted). Credit/Debit cards are accepted with a 3% convenience fee charged by the credit card company.
